SANCTIONING

The Max Bell Mantas Lifesaving Competition has been sanctioned by the Royal Life Saving Society Canada (RLSSC) and as such, any provincial records that may be broken will be recorded and submitted to AB/NWT Branch for processing. Rules governing this sanctioned event will include those from the Lifesaving Society Alberta Northwest Territories Competition Manual (2022 edition) and the ILS Competition Manual (2023 edition).

FORMAT

Lifesaving Society "SANCTIONED EVENT WARM-UP PROCEDURES" will be in effect through the event.
All events will be swum as time finals.

EVENTS

Manikin Relay, Manikin Carry, Tow with Fins, Medley Relay, Obstacle Relay, Obstacle Swim, Line Throw, Carry with Fins, Super Lifesaver, Rescue Medley, SERC

POOL SPECS

The swimming pool at the Max Bell Aquatic Centre is 1.8m deep for the entire length of the 25m pool and varies to 4.5m for the 50m pool. There are 8 lanes with two outside gutter lanes of 1.8-4.5m on either side of the pool.

EQUIPMENT

The host will supply Rescue Tubes, Rescue Manikins, custom obstacles and LSS Throw Lines for the use of competitors during the competition.

All competitors are required to supply their own fins.

All equipment will comply with the ILS specifications as specified in the ILS Competition Manual.
